

- 2. 接著,請在兩分鐘內,按住RE11S上的WPS按鍵 (約兩秒)啟動WPS連線功能。此時RE11S的綠色 WPS LED指示燈會呈現閃爍狀態,表示WPS連線 功能正在進行中。


3. 當RE11S的綠色WPS LED燈號轉為恆亮(恆亮狀態會持續約30秒),即表 示WPS連線已成功建立。




